Backorders	All backorders that qualified for PPD freight on the original order will be shipped PPD.	
USC Branch Pick-Up	Orders for stock merchandise and custom orders fabricated at USC will be freight free. Custom orders fabricated by vendors outside of USC will incur freight charges.	
USC Drop Ship Fee	All orders drop shipped to a consumer or non-USC account via USC delivery will incur a delivery fee. \$45.00 standard delivery fee, \$60.00 long route fee	
Missing Packages	USC will not be responsible for missing packages that were confirmed delivered.	
Residential Fees	Residential Common Carrier (truck) fees are in addition to normal freight charges even if the order qualifies for pre-paid freight. Residential fees are the responsibility of the customer.	
Special Access Delivery	All special access delivery fees are the responsibility of the customer. Example: Residential area fee, lift gate fee, inside delivery fee, remote areas, gated communities, ferries, tolls, storage units, and Driver Assistance fee (if applicable).
